FCA is Finland's largest international aid organization. FCA Operates in 13 countries in Asia, Africa and the Middle East.

Our main funding sources include:

- Ministry of Foreign Affairs, Government of Finland
- Women's Bank, Finland

FCA has been working in Nepal since 2013 focused on promoting the rights of vulnerable and marginalised groups facing various types of discrimination.

The long-term change that FCA wants to see in Nepal is that marginalized women and youth are socioeconomically empowered and enjoy a decent living.


Expected Change

- Access to quality education by supporting programmes on Education in Emergencies (EiE), Technical and Vocational Education and Training (TVET), Linking Learning to Earning (LL2E), and Education Sector Development
- Social inclusion, participation and non-discrimination through integration of Peace as a theme
- Women's empowerment and gender equality through focused intervention for women and girls
- Disaster affected people are supported through humanitarian livelihood and Education in Emergencies programs

Rights-Based Approach is the foundation of all FCA actions guided by international human rights standards and principles. FCA's experience has proven that equal access to information, participation and dialogue for both rights holders and duty bearers at different levels of governance, is the best way to build more just and equal societies.

TARGET GROUPS

FCA works with youth and marginalised groups such as former bonded labourers and Dalits.

Our work focuses on women

- support women and marginalized families to establish and operate small scale businesses to diversify income sources
- promote access to finance to rural women through establishment of women's groups and cooperatives
- establish market linkages for the women's groups and cooperatives to foster their business/enterprise
- strengthen women's leadership capacity and influence in society



RESULTS IN BRIEF



Right to Livelihood

9,904 individuals (5105 women and 4799 men) from vulnerable groups received vocational and business training for starting and promoting their own enterprise.

3,462 Private Sector Small Enterprise established of which 3,121 is owned by the women.

women led and owned cooperatives with a total of 9904 members were established and strengthen with FCA's support

1,506 former bonded labourers and Dalit youths received CTEVT certified vocational trainings.

Women's groups established and supported for women's economic empowerment such as skill development, enterprise establishment, business expansion, establishment/expansion of women's cooperatives and where applicable, to apply and receive grants from government



Right to Quality Education

666 classrooms constructed in 194 schools and 23,152 school children supported with early access to education in four of the 2015 earthquake affected districts.

12,000+ students supported with scholarship, ECD kits and stationeries.

school latrines and 272 handwashing stations constructed and renovated in disaster-affected in 272 schools.

schools supported to incorporate and implement DRR elements in School Improvement Plans.

2,190 teachers, child club members, school management committee members and parents trained on Disaster

21,314 schoolchildren from 61 schools accessed schoolbased psychosocial support programs.




Right to Peace

advocacy alliances formed, strengthened and mobilised at the local and district level in six districts of province 2 and 6 to identify and advocate on the issues of Dalits and the discriminatory practices in the communities.

4,000 Dalits (majority women) capacitated and informed on concurrent social issues through REFLECT.

14,725 Dalits reached through the Right to Peace programme to combat Caste-Based Discrimination (CBD) by restoring dignity, rights to non-discrimination, effective participation and access to services and justice of people affected by CBD.
